hough the first quarter of 2020 began on a busy note for stakeholders in the sugar industry, it was later slowed down by the outbreak of the Coronavirus pandemic towards the end of the quarter. The COVID-19 outbreak halted economic, social, political and corporate activities across countries, continents and regions.But amidst growing concerns on the impact of the pandemic on global activities, stakeholders in the sugar sector didn't drop the gauntlet as they forged on with their programmes, though skeletally.

During the period under review, the Senate Committee on Industries

embarked on oversight visit to sugar project sites in Kwara and Lagos states. According to the Chairman of the Committee, Senator Bayo Osinowo, the visit was to enable the committee assess the level of work so far done by the operators under the Backward Integration Programme (BIP) which is a critical component of the Nigeria Sugar Master Plan (NSMP).

In February, the NSDC signed a Memorandum of Understanding with the National Sugar Institute (NSI), Kanpur, India on training and capacity building for staff of the Nigeria Sugar Institute (NSI), Ilorin, Kwara state. The MOU

signing ceremony held at the Indian High Commission in Abuja.

Sadly, following the discovery of the index case of COVID-19 in the country, the Federal Government, through the Head of Civil Service of the Federation issued a directive to officers on grade level 12 and below to stay at home to curb further spread of the pandemic.

The Council also participated at the 41" Kaduna International Trade Fair which held between 28th February to 8th March 2020 in Kaduna state.

Senate Committee on Industry members tour sugar project sites

The Senate Committee on Industries led by its Chairman, Senator Bayo Osinowo recently visited major sugar project sites in Kwara and

Lagos states to monitor progress so far made with regards to the Backward Integration Programme commitments of operators in line with the implementation of the Nigeria Sugar Master Plan (NSMP).

While at the BUA project site, Alhaji Yaro briefed the

delegation on the level of progress so far made, projections as well as challenges facing the company. He said though efforts are on to ensure early completion of the project, but

highlighted paucity of funds, lack of access to land and dearth of infrastructure as well as insecurity as major problems confronting them.

He was however optimistic that the BUA Group would meet and surpass its targets and deliver on its promises given the enormous technical and financial resources it has invested in the project.

On his part, the Chairman Senate Committee on Industries, Senator Bayo Osinowo pledged his Committee's readiness to provide all the necessary legislative support and policies that would drive

development in the sugar sector, adding that the sector holds a lot of potentials for Nigeria and Nigerians.

In his remarks, the Executive Secretary of the Council, Dr. Latif D. Busari said government will continue to provide the right policies and enabling environment to protect investments in the sugar sector. He said all the challenges highlighted would be looked into by relevant government agencies.

proceeded to Lagos where it visited the Dangote Sugar Refinery. The delegation was received by the DSR Team and taken round its facilities.

While in Lagos, the delegation visited the Dangote Sugar Refinery and Golden Sugar Refinery where it was taken round both facilities by top members of the two organizations. They expressed satisfaction with their operations, and urged them to be innovative and leverage more on the opportunity provided by technology.

to train personnel of the proposed Nigerian Sugar Institute (NSI) located in Ilorin, Kwara state on factory operations.

Speaking at the event, the Executive Secretary, National Sugar Development Council, Dr. Latif D. Busari, said the collaboration with NSI would help address the challenges faced in the implementation of Nigeria's sugar master plan which was launched six years ago.

He said that one of the challenges was the lack of the technical manpower to run the sugar factories.

"As you all know that the Nigerian sugar master plan was lunched six to seven years ago, and it became clear that we have a serious challenge in terms of the technical manpower

He added that when established, the Nigerian Sugar Institute would benefit from the huge market available. "How it will factor into the Nigerian industries and energy is if you see the sugar master plan. "We will be able to generate more than 400 megawatts of electricity. We will produce more than 160 million litres of ethanol. These are if we are able to completely

implement the plan," he said.

Council officials visit KADIPA Executive Secretary

A four-man delegation from the National Sugar Development Council (NSDC) recently paid a working visit to the Executive Secretary of Kaduna Investment Promotion Agency (KADIPA) Hajiya Umma Aboki to discuss on areas of business collaboration and partnership between the two organizations.

Leader of the delegation and Deputy Director, Policy, Planning, Research and Statistics (PPRS), Alhaji Babangida Abba Damare said the visit was to formally introduce the Council to KADIPA boss, explore investment opportunities in the sugar sector and share experiences on how to create a business friendly environment.

Alhaji Damare who said the Council is presently implementing a ten-year master plan for the sugar industry known as the Nigeria Sugar Master Plan (NSMP), reiterated Council's determination to ensure faithful implementation of the master plan.

He further stated that the Master Plan projected that for Nigeria to achieve its domestic sugar targets, "the country needs to establish some 28 sugar factories of varying capacities and bring about 250,000 hectares of land into sugarcane cultivation, on which some sites fall within Kaduna State". He cited Sugarcane Growing Areas of Dutsin – wai, Makarfi, Giwa, Ikara etc. as potential sites for sugar investments.

Responding, the Executive Secretary of KADIPA, Hajiya Umma Aboki said the current administration under the leadership of Governor Nasir El-Rufai believes that industrialization is the panacea to the growing rate of unemployment in the state and Nigeria as a whole. She said the agency under her watch will continue to evolve programmes and policies that would promote investments in the state.

Hajiya Umma Aboki who commended the Council for designing a policy roadmap for the sugar sector, said KADIPA would carefully study the document to enable her understand the contents.

The Council team comprised of the Deputy Director, PPRS, Alhaji Babangida Abba Damare, Assistant Director, PPR, Hajiya Fatima Bobbo, Suleiman Mohammed Kabir and Abdullahi Habib.

COMPULSORY STAY AT HOME OF NON-ESSENTIAL PUBLIC SERVANTS ON GL GRADE 12 AND BELOW AS A FURTHER MEASURE TO CURTAIL THE SPREAD OF COVID-19

- As you are no doubt aware, the Federal Government has taken a number of measures to manage the identified cases of covid-19 and curtail it's spread.
- Government is concerned about the welfare and safety of all public servants just as it about other
 Nigerians. All public servants are, therefore, strongly advised to follow the measures being put in place by government to curtail the spread of the pandemic.
- As a further step to check the spread of COVID-19, all non-essential public servants on grade level 12 and below are to stay and work from home with effect from Tuesday 24th March, 2020 until further notice.
- All other categories of officers who will be at work, to limit the number of visitors they receive to the barest minimum. This is to reduce physical contact as much as possible.
- Furthermore, officers who have recently visited Countries with incidence of COVID-19 or, have had
 contact with persons who recently returned from these countries, are advised to self-isolate at home
 for 2 weeks. In case such officers exhibit any of the
 COVID-19 symptoms, they are advised to contact the National Centre for Disease Control (NCDC) on 0800970000-10.
- For the purpose of emphasis, observance of strict adherence to personal hygiene, including frequent washing of hands with soap and running water, is strongly advised.
