BIP in sugar sector will provide more jobs for Nigerians, says Mr. Adedeji

he Executive Secretary of the National Sugar Development Council (NSDC), Mr. Zacch Adedeji

has said that the Backward Integration Programme (BIP) roadmap designed for the nation's sugar industry, which is a major component of the Nigeria Sugar Master Plan (NSMP), has the capacity to tackle soaring unemployment level and also address other socio-economic issues currently bedeviling the country.

Mr. Adedeji who said this while on a familiarization visit to sugar refineries in Lagos state, linked violent crimes and insecurity to rising unemployment and joblessness amongst the youths in the country, noting that the sugar sector as presently structured has what it takes to provide direct and indirect jobs for millions of Nigerians both as skilled and unskilled workers.

"The sugar sector is a goldmine that holds numerous potentials and opportunities for Nigeria and Nigerians. It is a sector that has provided direct and indirect jobs for thousands of our citizens across disciplines and professions. We are all concerned about the need to provide job opportunities for our people, especially our youths. Unemployment is a major contributor to the various social crises facing us today as a country.

Nigeria hopeful of \$700m yearly from sugar backward integration, Alhaji Dangote

angote Sugar Refinery Plc has urged the government to faithfully follow through with the Backward Integration Policy (BIP) in the sugar industry as the nation stands to rake in foreign exchange up to \$700millon yearly from Sugar production self-sufficiency.

Chairman of Dangote Group, Alhaji Aliko Dangote while addressing shareholders, at the company's 15th yearly general meeting held in Lagos recently said, allowing for distortions in the sugar master plan framework will adversely affect the target of the nation attaining self-sufficiency as projected.

He described the backward integration policy as commendable, which will not only reduce imports of raw sugar but save the nations enormous foreign exchange used for importation.

Alhaji Dangote expressed delight that the BIP in the sugar industry is going on well, noting that if the national sugar master plan is followed strictly and the players

follow the rules, Nigeria will save between \$600 million to \$700 million yearly as foreign exchange.

He stated that the backward integration policy of the company is recording appreciable progress even as he expressed the company's commitment to the policy.

He said despite the disruptions in the economy occasioned by the

covid-19 pandemic, the company recorded an increase in production volume which rose by 13.7 percent to 743,858 tonnes in the financial year ended December



31, 2020, compared to 654,071 tonnes in 2019.

He stated that the company posted a group turnover of N214.3 billion, 33 percent increase over the N161.1 billion in 2019, while in the same period the Sugar Group also posted 6.9 percent rise in sales volume from 684,487 tonnes in 2019 to 731,701 tonnes in 2020.

The company's gross profit increased by 40.4 percent to N53.75 billion, compared to N38.29 billion in 2019 while group profit after taxation for the year increased by 33.2 percent to N26.70.billion against N22.36 billion in 2019, reflecting management's unrelenting goal to deliver consistent shareholder value.

Dangote said the company has revised its sugar production target to 550,000 metric tonnes achievable by 2024 in line with the revised plan on the BIP by the federal government.

In his remarks, the Group Managing

Director/Chief Executive Officer, Ravindra Singhvi, speaking on the results said the sugar group continued the growth path with commitments to improve performance and generate value for all stakeholders.

He explained that this was reflected in the sales volume delivery of 731,701 tonnes, and production of 743,858 tonnes being 6.9 per cent and 13.7 per cent increase in volumes over the comparative year

BUA Group's \$300m sugar refinery in Lafiagi to be completed by Q1 2022

Backward Integration Programme (BIP) agreement, BUA Group says the construction of its sugar refinery in Lafiagi, Kwara State will be completed by the first quarter of 2022.

at the moment. Other sugar plantations do not have this kind of capacity.

"We are not stopping at the mill because that is the brown sugar you see, but we are migrating to a refinery, we are going to be refining the sugar. So, we have the refinery under construction at the moment, and we are building a power plant-a 35 megawatts power plant and part of it would be solely for the refinery and part of it would go to the national grid".

Speaking on the contribution of the project to Nigeria's economy, Mr. Olayiwola said the refinery will create 5,000 jobs for direct staff and indirectly create over 10,000 jobs for ancillary staff.

On the infrastructure development part of the project, he said the plantation on completion will have a school, a hospital, road networks linking the refinery to neighbouring communities, canals to bring water from river Niger for irrigation and over 200 housing units of different types for staff.

Nasarawa Government, Flour Mills sign \$300m MoU for sugar production

he Nasarawa State Government and Flour Mills of Nigeria have signed a Memorandum of Understanding (MoU) for a \$300 million investment in sugar production.

Under the MoU, the state leased 20,450 hectares of land to Flour Mills of Nigeria for 50 years, during which the company is expected to ramp up the Backward Integration Plan (BIP) in sugar production as provided in the Sugar Master Plan of Nigeria.

At the event in Abuja, the governor of Nasarawa State, Abdullahi Sule, said the investment would create jobs for the people and advance wealth creation, assuring the investor of security in the area.

The group managing director/chief executive officer of Flour Mills of Nigeria Plc, Boye Olusanya, said the company was investing \$300 million on the 20,450 hectares of land in Toto, Nasarawa State, out of which 15,000 will be used for sugarcane plantation and the rest for supporting infrastructure.

He said the latest investment was in addition to the investments at Sunti, Niger State, which is on record as the first green field investment

In his remarks, the Executive Secretary of the National Sugar Development Council, Mr Zacch Adelabu Adedeji, said the investment brought Nigeria closer to the realisation of the targets of the National Sugar Master Plan, aimed at making the country self-

sufficient in sugar production. There is a similar project on sugar by Dangote.

Depression is a severe condition that affects millions of people worldwide. Yet, if two depressed people compare their symptoms, they often find that they're quite different from each other. - Depressed mood
- Changes in sleep, appetite, and weight
- Less activity or more agitation
- · Trouble concentrating
- · Low energy
- · Feeling hopeless or guilty
- · Physical aches and pains without a clear physical cause

· Suicidal thoughts

Types Of Depression

Although the above symptoms may appear in any type of depressive disorder, each type has a unique blend, triggers, and presentation of them. Here are brief descriptions of various kinds of depression and what makes them unique.

Major Depressive Disorder


Major symptoms of MDD are lack of interest in things once enjoyed you've had a manic or hypomanic episode, the diagnosis probably won't be MDD.

Persistent Depressive Disorder

Persistent depression, sometimes called dysthymia, is a type of depression that lasts at least two years or longer. Within those two years, the symptoms may get better or more severe, but they're present at some level throughout that time.

Bipolar Disorder

Bipolar disorder, also known as manic depression, is a condition in which depressive symptoms alternate with manic or hypomanic symptoms. During the depressive phases, you may have any of the general depression symptoms. While you're in the manic phase, you might have symptoms like



and a sad or depressed mood. To rapid speech, grandiose ideas, receive this diagnosis, one or both must be present, as well as three or four of the others, for a total of five of the symptoms above. The signs must be severe enough to interfere with daily life. Also, they must not be due to grief, substance abuse, a medication or another medical condition, a psychotic disorder, or a schizophrenic disorder. Finally, if Seasonal affective disorder is a

elevated mood, and others. Hypomania is similar to mania, but it's less extreme. If you have bipolar disorder, you may also have times when you are neither depressed nor manic or hypomanic.

Seasonal Affective Disorder (SAD)

depressive disorder that begins in the winter months and lifts in the spring. It may be related to the amount of natural light available during the day. Seasonal depression usually has symptoms like social isolation, weight gain, and oversleeping. SAD comes back every winter, year after year.

Perinatal Depression

Perinatal depression happens when a woman is pregnant. It can also occur after birth, in which it is sometimes called postpartum depression. This condition has the symptoms of major depression, and the most common for this disorder are anxiety, sadness, and fatigue. The symptoms may be severe enough to interfere with the mother's ability to take care of her infant correctly.

Premenstrual Dysphoric Disorder (PMDD)

Some women experience cyclic depressions that correspond to their menstrual cycles. Premenstrual dysphoric disorder (PMDD) is a hormone-related moor disorder. It is a more severe condition than PMS, and it typically interferes with life for several days before the woman's period. This disorder has physical symptoms, along with the usual symptoms of depression. Irritability is common.

Disruptive Mood Dysregulation Syndrome (DMDD)

Another recently identified type of depression is disruptive mood dysregulation syndrome. DMDD's most common symptoms are irritability and temper outbursts. It's primarily diagnosed in children. Unlike the episodes of irritability in bipolar depression, the irritability in DMDD is persistent and severe.

Treatments For Depression

Treatment is important in managing depression. The most effective



treatment depends on the type of you depends on factors like specific depression, as well as factors that type and severity of your disorder as are unique to you as an individual. The following are some of the treatments your doctor or therapist might recommend.

Medications

A wide assortment of medications is available for depression treatment. The first-line medications for many types of depression are antidepressants. These include:

- Selective serotonin reuptake inhibitors (SSRIs) like Prozac, Paxil, or Lexapro
- · Serotonin and norepinephrine reuptake inhibitors (SNRIs) like Cymbalta or Effexor XR
- · Tricyclic antidepressants like Tofranil or Pamelor
- Monoamine oxidase inhibitors (MAOIs) such as Parnate or Nardil
- · Atypical antidepressants, such as Wellbutrin SR

For those with manic depression, your doctor might prescribe a mood stabilizer, and possibly an antidepressant and other medications, too.

Psychotherapy

Psychotherapy can be helpful for nearly any mental disorders you might have. The best therapy for

well as your personal preferences. Regardless of the type of therapy you choose, your counselor may adapt it to suit you as an individual. Both cognitive behavioral therapy and interpersonal therapy have been shown effective in many research studies and clinical practice.

Cognitive Behavioral Therapy (CBT)

Many psychologists recommend CBT to patients with various depression disorders. This type of therapy involves learning to recognize negative thoughts and behaviors. The next step is to change negative or inaccurate thoughts and behaviors that might be contributing to the depression. Your therapist acts as your guide and encourager during this process, while you are the one who learns and practices these techniques.

No matter what depressive disorder you might have, a doctor or counselor can help you in your quest to relieve the symptoms and get back to a happier life. You can talk to a psychiatrist or doctor in your local community to get started with diagnosis and medications.
